

**2008 Louisiana State Appaloosa Club
Stallion Service Breeding Agreement**

We/I the owner(s) of the stallion _____ registration number _____ donate, transfer and assign a stallion service to the LSAC for the year 2008 to the above named stallion. It is expressly understood by all parties to the agreement that this Breeding Service is assignable only by the LSAC pursuant to the terms and conditions of its annual stallion service auction for the year in which said breeding applies, said terms and conditions being incorporated herein by direct reference thereto. All parties to the agreement are further bound and agree to the following terms and conditions.

1. That the breeding season in force for this contract being February 1, and closes July 31, and mare owner shall be entitled to one return privilege in the following year for the same mare, or in the event of the death of said mare (or vet-certified breeding unsoundness), a substitute mare.
2. That should the above said stallion die or become unfit for breeding purposes and said mare had not been serviced by said stallion, then any money paid by mare owner to the LSAC Futurity shall be refunded (as credit in future auctions) upon proper verification of the above from the stallion owner.
3. That stallion owner/manager will not be responsible for any disease, accident, sickness, and/or death of mare or foal, and similarly mare owner will not be responsible for any disease, accident, sickness, and/or death of stallion.
4. That mare, in order to qualify for this breeding service, must be halter broken.
5. That board or shipping services will be charged to mare owner by stallion owner at the following rates:

- 8. That Breeder's Certificate shall be furnished to the mare owner at the time stated in the stallion contract. If it is not stated in stallion contract then the Certificate will be furnished after there is a viable foal and all fees have been paid.
- 9. The mare owner may choose either a weanling class or a yearling class at the time of breeding. The money from purchase will go to the selected class. The mare owner will not have to pay the entry fee for this one selected class.
- 10. That the advertised breeding fee for this stallion for the year 2008 is \$_____.
- 11. **That the deadline for stallion service donation is August 1, 2007. This service must be purchased & fulfilled by July 31, 2008 in order for offspring to compete in the 2009 weanling halter class.**
